Pupils will often appear in these images, which may appear in local or national newspapers, or on televised news programs. Photography or filming will only take place with the permission of the head teacher and under appropriate supervision.

We request your permission to photograph or make any recordings of your child for promotional purposes.

Conditions of use

1. This form is valid for the period of time your child attends the school. The consent will automatically expire after this time.
2. We will not use the personal details or full names (which means first name and family name) of any child or adult in a photographic image on video, on our website, in our school brochure or in any of our other printed publications.
3. We will not include personal e-mail or postal addresses, or telephone or fax numbers on video, on our website, in our school brochure or in other printed publications.
4. We may include pictures of pupils and teachers that have been drawn by the pupils.
5. We may use group or class photographs or footage with very general labels, such as "a science lesson" or "making decorations". Children will not appear in close-up in a group photograph.
6. We will not use potentially embarrassing or distressing images and images will not be associated with distressing or sensitive issues.
7. We will only use images of pupils who are suitably dressed.

Please note that websites can be viewed throughout the world and not just in the UAE.

Consent Form: For Use of Photographic Devices at School Events by Parents, Guardians or Carers.

At Aldar Academies our aim is to protect pupils, family and staff from inappropriate use of photographic images, whilst acknowledging that families wish to photograph or film their children at school events throughout their school career.

Parents / carers are welcome to take videos and digital images of their children at school events for their own personal use. To respect everyone's privacy and in some cases protection, these images should not be published or made publicly available on social networking sites. Photographs or videos generated by parents at school events are for the sole use of the family concerned. They are not for display, distribution or any other purpose outside of that family

Parents / carers should not comment on any activities involving other students in the digital / video images.

We therefore ask parents to sign this consent form. This will be retained on your child's school records while they attend this school.

Parents need to understand that where they feel unable to agree to the statement limiting the taking and use of photographs for family purposes only, they will be prohibited from taking such photographs and videos in school.

Where parents feel unable to give consent for their child's photograph to be taken during school activities by other parents in school, it will be necessary to exclude their child from certain school events and activities.
